- a. <u>Personnel</u>. During the period of this report, one officer was added to the unit and three officers transferred out of the unit.
- b. Administration. The Detachment Administrative section has effectively maintained the unit's records, basic correspondence, SRB audits, message releases, and reports during the period.
  - c. Intelligence. Negative Report.

### d. Training

(1) During the course of the 12 months covered by this report, priority has continued to be placed on maintaining qualification and expertise of redeye gunners. In excess of 100 hours have been devoted to Redeye training. This training has

consisted of aircraft recognition, tracking head training, map reading, communications and associated military training.

- (2) The unit accomplished ATD in several phases.
- (a) During 3-16 May the unit participated in the NATO exercise "Dawn Patrol" in Italy. From Det "A" 6 enlisted personnel along with 1 Officer, 1 Staff NCO and 6 enlisted from Pasadena were implemented into this problem. These Marines provided anti-air defense for the 32nd MAU. Cross training with other NATO units occurred.
- (b) During 1-15 July, 3 Officers and 22 enlisted conducted an ATD at MCAS Cherry Point/Bogue Field. A Redeye Launch Simulator firing exercise FIREX was conducted at Bogue Field. Aircraft utilized for targets in RELS firing consisted of A-4's, A-6's, AV-8A's and OV-10A's. Other training conducted by Det "A" 4th FAAD, while on ATD consisted of the following:
  - 1 Swimming/Drown Proofing.
  - 2 Marksmanship Training with M-16.
  - 3 Marksmanship Training with .45 Caliber Pistol.
