PART II

NARRATIVE SUMMARY

- 1. During January, Battery "A" deployed to MCTSSA, Camp Pendleton, California, for compatibility test of the Improved TACC with the Improved Hawk missile system. Highlighting the month was Battalion wide Practical Essential Subject Testing at the P-111 Desert Site. MACS-24 deployed to the P-111 Desert Site in late January for their annual reserve training.
- 2. During February, MACS-24 completed an extremely successful ATD cycle that included their first MBDL Operations. A briefing was conducted on the IHAWK Missile System and Redeye for a WTI class. "B" Battery deployed to Niland, California, to participate in Operation Spear Blunt. Three Marines in the Battalion participated in the wear-testing of possible new covers for field and garrison wear.
- 3. Throughout the month of March, a number of enlisted Marines from the Battalion assisted with the Yuma County Special Olympics Program. IHAWK Modification Team performed major equipment modification during the month. "B" Battery departed for embarkation to Hawaii on Operation Aloha III, an IHAWK-TAOC MBDL exercise. The Battalion participated in a quarterly Safety Standown at the end of the month.
- 4. During April, a number of tours and lectures were presented to MCJROTC High School students from El Toro, California; Brownsville, Texas; Albuquerque, New Mexico; and New Orleans, Louisiana on the Improved HAWK Missile System and Battalion Mission and organization. A FSMAO Inspection of all maintenance and supply units was conducted with overall satisfactory results. Brigadier General TWOMEY, Commanding General of 1st Marine Brigade and Colonel THATCHER, Commanding Officer of MAG-24 visited "B" Battery while deployed in Hawaii on Operation Aloha III.
- 5. In May primary emphasis was placed on Operation Streaker VI, the annual service practice live firing exercise for "A" Battery and "C" Battery. The Operation was viewed by representatives from Redstone Arsenal, Raytheon Company, and WTI students. The Operation was an outstanding success with the Battalion extablishing several "first" firing from the Improved Platoon Command Post, to include:

 1) The first successful Marine Corps firing from an IPCP; 2) The first successful Marine Corps firing in the normal ADP mode; 3) The first successful firing by any tactical U.S. Unit of a fully automatic ADP IHAWK shot. "B" Battery returned from a very successful deployment to Hawaii. At the end of May the Battalion sponsored a Field Meet to raise funds for the Navy Relief Drive.

6. During early June the Battalion received a staff visit by Colonel MCCAMEY, Commanding Officer of MACG-38. H&S Battery and B Battery participated in Operation Harbinger, the final exercise for WTI students. The Battalion stood down in mid-June for a Quarterly Safety Standown. At the end of the month the Battalion received a staff visit by Brigadier General MALONEY, Assistant Wing Commander for Third Marine Air Wing. On the last day of June, the Battalion joined its first Woman Marine, 2nd Lieutenant J.A. TAYLOR who will become a 7204 HAWK Officer.
