Narrative Summary

1. Command, Operations, and Training

4th FAAD Battery (-) received instruction to increase their proficiency in their MOS skills during homesite drills. 7200s received instruction in aircraft identification, land navigation, weapons employment, and engagement procedures. 2500s received instruction in equipment maintenance and communications procedures. 4th FAAD Battery (-) conducted three ATDs during the year. They included a group level command and control exercise at Dugway, Utah, CAX 8-87 at Twentynine Palms, California, and WTI 1-88 at MCAS Yuma, Arizona. In addition, off-site drills were conducted for operational employment of FAAD equipment.

The battery has continued to recruit both prior and non prior service personnel to fill shortfalls in the T/O.

NARRATIVE SUMMARY1. Command, Operations, and Training.

a. Intelligence

(1) 200 new security investigations were initiated during this period.

(2) Intelligence briefs were given before and during ATD's.

(3) MAWTS Intelligence briefs were given to all Officers and Staff NCOs of the unit during the Nov 87 drill periods.

b. Training

(1) During the 12 months covered in this report priority was given to maintaining Stinger Team Proficiency. ATDs were scheduled to enhance proficiency as Stinger Gunners. Participation in WTI 2-87 and Red Flag 4-87 were significant to Stinger training and development. Communicators both conducted and recieved classes on communication procedures and security. All Essential Subject Testing and Physical Training were accomplished to a level satisfactory with present Marine Corps standards. A PFT passing rate of 98% was achieved by this unit. The unit's ATD percentage was 95%.



SECTION 2

NARRATIVE SUMMARY1. Command, Operations, and Training

a. Training

(1) The Squadron completed rifle requalification training at MCRD Parris Island during October when more than 90% of the Marines requalified. Marksmanship training for 1987 was satisfied.

(2) Pistol requalification training was completed during August when 16 shooters requalified with the T/O weapon.

(3) The Squadron conducted it's annual PFT in June and achieved a passing rate of 97%. Through remedial training, those who failed to pass subsequently achieved at least third class status.

(4) 100% of those required to complete essential subjects testing did so successfully during the year. In addition, the Squadron completed NBC operations through use of the County Fair Concept.

b. Operations

(1) Significant growth in manpower, training improvements, and technology incorporation.

(a) The addition of two school trained Maintenance Officers has permitted a better division of responsibility and permitted an immense improvement in the Squadron's ability to administer the various programs required by OPNAVINST 4790.2. Department on-hand strength increased by 30% during the year.

(b) A squadron mobile maintenance van exercise was conducted on site during 11-14 Sept 1987. Five mobile maintenance vans were moved to the closed runway at Dobbins AFB. All squadron maintenance and supply functions were conducted at the van site. Significant lessons were learned and mobilization training was conducted.


