PART II

NARRATIVE SUMMARY

- 1. During July the Battalion held training and instruction in NBC Warfare, with emphasis on protection and survivability. The Battalion held a training stand-down to complete essential subjects ranging from Basic Radar Principles, Survivability, Evasion, Resistance and Escape to Voter Information and Leadership. An Assualt Fire Unit deployed to the Fortuna Wash area from Battery "C" for field exercises. The exercise was supported by elements from the Battalion Communications and Motor Transport Platoons. Seven Redeye personnel from Battery "C" who participated in Camp Pendleton's MAFIEX 7 Operation returned. Battery "C" was inspected for embarkation readiness as was Battery "A"'s equipment.
- 2. August was highlighted with the Battalion Change of Command. Lieutenant Colonel M.A. HOLDER was relieved by Lieutenant Colonel B.J. SPEIGHTS. The Battalion Safety Standdown emphasised instruction in Desert Survival, Drug and Alcohol Abuse, Fire Prevention and Air Station Safety. Battery "C" conducted extensive training in Electronic Security, Electronic Counter Measures and Electronic Counter Counter Measures at the 2301 target area. The battery received support from Motor Transport. During the month Motor Transport Platoon also supported the Station EOD unit. Battery "C" was inspected for security of classified material by the Battalion S-2. The Battalion received a new Supply Officer with 1st Lieutenant E.R.ELDER replacing 1st Lieutenant W.C.BELL.
- 3. In September the Battalion was briefed on the Warsaw Pact threat forces by 1st Radio Battalion FMFPac. Battery "C" and Communications personnel participated in Electronic Warfare and Counter Measures. Battery "B" conducted similar exercises in conjunction with Weapons Training Instruction at Bakers Peak. Battery "A" continued the emphasized training at Raven Butte. Also during the month the Wing Administration and Maintenance Inspection was held, followed by the 3rd MAW Administration and Assistance Team inspecting Headquarters and Service Battery. 2rd LAAM Bn Embarkation and Ground Safety program was inspected by the MACG-38 staff. Major J.W.CHILDS, Battalion S-4, received orders and was replaced by Captain R.E.BALL.
- 4. During October MIMMS classes held by 1st Lieutenant HILL were given to 12 Marines representing all Battalion units. Batteries "A", "B"and"C" were inspected for embarkation readiness by 1st Lieutenant GARIFE who also inspected Headquarters & Service Battery office, Headquarters Platoon and Motor Transport for ground safety. October was the month for inspections with the Battalion MMO inspection preceding the I.G. inspection. Battery "C" had 7 days of continuous operation prior to commencing IHAWK FIREX HOTSHOT I which successfully ended the month.

- 5. In November the 203rd Birthday of the Marine Corps was celebrated. The 4th IAAM Battalion received training with assistance from Battery "A". Battery "A" deployed to Camp Pendleton for VARSITY LANCE exercise. Battery "B" conducted exercises in various forms of antiair warfare. Battery "C" deployed to White Sands Proving Grounds for the Target Tracking Missile Test.
- 6. During December Battery "C" continued the Target Tracking Missile Test at White Sands Missile Range. Upon return Battery "C" conducted Mode 4 checks with assistance from various Marine aircraft stationed at MCAS Yuma. Battery "A" participated in Fleet Exercise VARSITY LANCE which concluded during the month. 4th LAAM Battalion again received training from Battery "A" in joint exercises.
