NARRATIVE SUMMARY

1. Command, Operations and Training.

Battery personnel continuously involved in major Marine Corps exercises to include the Combined Arms Exercises (CAX) and Amphibious Exercises (PHIBLEX). Training conducted included tactical use of Redeye, land navigation, rifle requalification, essential subjects testing and personal affairs program.

d. Training.

- (1) During the course of the 12 months covered by this report, priority was placed on maintaining qualification and expertise of FAAD Gunners. 140 hours have been devoted to Redeye/Stinger training. This training has consisted of Aircraft Recognition, Tracking Head Training, Map Reading, Communications, Small Unit Deployment and Tactics, and associated military training. The unit achieved over a 90% completion rate for MCI courses and a 97% passing rate for the PFT. An exemption was given for Rifle qualification. Familiarization firing was accomplished with the M-16 service rifle 22 23 September.
 - (2) Unit training accomplished during ATD is as follows:
- (a) During 28 April 11 May 1984 47 Marines participated in WTI 1 at MCAS Yuma, Arizona.
- (b) During 7 July 21 July 11 enlisted Marines participated in CAX at MCAGCC 29 Palms, California.
- (c) During 7 July 21 July 1 officer attended CMD STAFF PHASE I at MCDEC
- (d) During 15 July 27 July 1 officer attended the Warrant Officer Basic School at Quantico, Virginia.
