NARRATIVE SUMMARY

Command, Operations, and Training

The operational tempo combined with the ongoing reorganization of MACS-1 and numerous equipment and personnel changes presented significant challenges to the Squadron during the second half of 1998.

In July the TAOC Det deployed Marines to MCTSSA at Camp Pendleton to prepare for deployment to Kuwait as part of Marine Corps Functional Inoperability System Test (MCFIST). They conducted testing and gear familiarization involving the AN/TPS-59 (v)3 Radar, the AN/TYQ-23(v)4 Tactical Air Operations Module (TAOM), the AN/MSQ-124 Air Defense Communications Platform (ADCP), the AN/TYQ-82 Tactical Digital Communications Platform (TDCP), the AN/TYQ-87 Sector Anti-Air Warfare Facility (SAAWF) and the AN/MPQ-62 Continuous Wave Acquisition Radar (CWAR). Additionally, the TAOC Det provided a TAOM Data Link Node to support 4th LAAD Bn. as part of the USAF Red Flag exercise at Tonapa, NV.

The EW/C Det spent most of July working to complete the reorganization process resulting from the merger of MACS-7 and MACS-1. While disposing of excess equipment and spare parts the Detachment also began to lose significant numbers of personnel while downsizing to the new Table of Organization. In the midst of the reorganization, the EW/C Det continued to provide GCI to MAG-11 and augmented the Tactical Air Command Center (TACC) at MCAS El Toro during MEFEX.

Air Traffic Control Det A Completed their move into the EW/C work site. While ATC Det B and ATC Det D continued planning for their relocation from MCAS El Toro to MCAS Miramar. ATC Det C completed a Fleet Grooming inspection by SPAWARSYSCEN, NRAD, San Diego, CA.

The beginning of August saw the Squadrons focus shift from internal restructuring to exercise support. On 13 August the Squadron deployed Marines from three Detachments to Ali Al Salem Air Base, Kuwait, to support MCTSSA's Marine Corps Functional Interoperability System Test. The primary focus of the test was the new AN/TPS-59 (v)3 Radar. During the test the AN/TPS-59 (v)3 Radar was interfaced with the AN/TYQ-23 (v)4 TAOM and ADCP via Point to Point Data Link. In addition the TDCP was used to provide a TADIL-J link between the TAOM and ADCP. Additionally the CWAR was integrated into the system. The Squadron also provided Marines from the EW/C Det to support GuardEx, which involved the U.S. Customs Service and National Guard. ATC Det A and D underwent the Fleet Grooming inspection by SPAWARSYSCEN, NRAD. The Squadron conducted a Maintenance Management Inspection on 31 August.

During the month of September the TAOC Det became the first Fleet unit to receive the AN/TPS-59 (v)3 Radar. During the same time period the Det was also responsible for the divestiture of the AN/TPS-59 (v)1 version and the integration of four AN/MPQ-62 Continuous Wave Acquisition Radars. The TAOC performed the mission of a Regional Air Direction Center during JSTE 98-03. The TAOC provided Air Intercept Controllers to German Fighter Weapons Instructors Course at Hollomon AFB. The EW/C conducted training on operations, maintenance and integration of the CW Radar. The month of September also saw 2 Marines from ATC Det B and C deploy to Poland as part of a Joint Contact team. The Squadron closed out the month with an Embark Readiness Inspection, and the move of ATC Det D personnel to MCAS Miramar.

The month of October would prove to be the busiest month of the year, as virtually the entire squadron was involved in supporting three major exercises simultaneously. The Squadron supported WTI 1-99 MATCALS with equipment from ATC Det C, an AN/TPS-73 from ATC Det D, MMT from ATC Det B, and Sector Acquisition Sections from the TAOC.

During CAX 1/2-99 the TAOC Det deployed to MCAGCC 29 Palms, CA and provided a Tactical Air Direction Center and one SAS. ATC Det A and B provided augments to the AGSE for airfield operations. In support of WINGEX the TAOC deployed to MCAGCC 29 Palms Camp Wilson and Gold Mountain Big Bear, CA and were critical components in providing the recognized air picture and digital information link connectivity to the Aviation Combat Element. The Det Also deployed the last of its four SAS's. The EW/C supported WINGEX from garrison at MCB Camp Pendleton by providing data link operations, GCI and TATC support for aircraft flying in the W291 training area. During this time frame ATC Det D moved all tactical and support equipment to MCAS Miramar as part of the BRAC move, and the EW/C Det took delivery of the Squadron's second AN/TPS 59(v)3 Radar.

The month of November saw the conclusion of WTI 1-99 and continued support of CAX 2-99. The EW/C Det conducted acceptance testing and NET training for the AN/TPS 59(v)3 Radar. On 18 November ATC Det C began providing PAR/GCA services for MCAS Yuma while the station underwent extended field maintenance. ATC Det B participated in Desert Knight and Desert Thunder exercises as well as providing six Marines for a MEF Deployment Readiness Exercise. ATC Det D sent Marines from their NAVAIDS and Comm sections to NRAD, San Diego for technical assist and repair/modifications. On 23 November a group of British Royal Marine Officers toured the Squadron during their study of the Marine Air Command and Control System.

The month of December brought welcome relief from the high operational tempo of the preceding months. During the first week of December the squadron conducted Maintenance Management Inspections of all commodity areas in preparation for the upcoming FSMAO assist visit in January. From 2-11 December, 53 Marines from the EW/C Det took virtually all the detachment's assets and established an EW/C site at Red Beach on Camp Pendleton. The internal exercise, dubbed Lightning Strike, was the Det's first opportunity to deploy the AN/TPS 59(v)3 Radar. As the month of December came to a close, the squadron was looking toward the new year and preparations for deployment to White Sands Missile Range in support of Patriot testing.

Personnel and Administration

The tempo of administrative activity remains high. Marines from MACS-1 continue to support the Consolidated Personnel Administration Center aboard MCAS Yuma. The Adjutant section continues to provide administrative and legal support to the Squadron Headquarters and coordinates administrative activities with the Marine Air Control Group 38 staff. During this period, there were several personnel staffing changes throughout the Squadron due to the divestiture of the HAWK missile system from the Marine Corps inventory.

Intelligence

The Squadron intelligence section continued to provide support to the Squadron staff and detachments. They maintained squadron-wide security procedures and they provide intelligence updates to the squadron officers on several areas of interest including the Middle East and Asia. In addition, they provided intelligence updates, maps, and Tactical Aircrew Mission Planning Systems (TAMPS) diagrams for squadron units during all their exercises.

Logistics and Supply

The logistics and embarkation sections maintained their extremely high operational tempo in support of the squadron. This section provided logistical support for transportation of things (TOT) and transportation of personnel (TOP) for all the squadron exercises and deployments as well as day to day support of subordinate detachments.

The Hazardous Materials section made significant progress in reducing the amounts of hazardous materials maintained by the squadron. The section continues to train and monitor the education of squadron and detachment personnel assigned to HazMat billets.

Communications and Electronics

Throughout this period the S-6 office Information Systems Coordination section (ISC) continued to provide Local Area Network (LAN) connectivity within the squadron. A plan was developed for upgrading the LAN topology from a shared, 10mbs, bus topology to a dedicated 100mbs star topology. A fiber-optic based solution for our LAN backbone was developed. Non-secure e-mail/LAN access to deployed units at site 50 with seven nodes, including Internet access was provided during WTI 2-98. Over one third of MACS-1 computers have been upgraded to meet IT21 standards. TCP/IP protocols on Banyan servers and Microsoft Windows 3.1x and Windows 95 client platforms were implemented squadron wide for Internet access. The section successfully

transitioned the squadron between Banyan VINES 3270 services and TCP/IP based 3270 access using Hummingbird's Host Explorer application, and Implemented 2 Class C IP networks. The section began an initiative to enhance the data transfer medium between MCAS Yuma and this site at CADC, and incorporated an addressing strategy in support of the merger of MACS-1 and MACS-7 including an ISC support plan for the four detachments located at MCAS Miramar and Camp Pendleton. ISC stood up new LAN topology plan for two ATC detachments after their move from MCAS El Toro to MCAS Miramar, and initiated and completed numerous Y2K studies to prepare MACS-1 for the new millennium. Five Banyan servers were upgraded from VINES version 5.54(20) and 6.30(0) to 7.10(0) and 8.50(1).

LAN and Internet access was installed at ATC Det C resulting in "hard wired" LAN access for the first time since the Det was stood up in 1994. The Operational Communications and Communications Maintenance sections supported WTI 1-99, MCFIST, WINGEX, CAX and RED FLAG exercises with voice and data connectivity as well as 1st through 4th echelon maintenance support. The S-6 office has completed the integration of the MPQ-62 radar and personnel into the TAOC Detachment's radar section. The divestiture of HAWK lead to removal of multi-channel radio capability and transfer of all associated personnel. MARCORSYSCOM training team was hosted to teach the USM-646 Test Set to technicians and maintainers. CMS initiated the implementation of the EKMS system as well as the training of EKMS CMS personnel. A special CMS inventory was completed for the turnover of our CMS Custodian and we recieved a noteworthy result from a CMS A&A team inspection.
