2. Sequential Listing of Significant Events, Relating to:

- a. Personnel. A Change of Command took place in December.
- b. Administration. In August 1ST. LT. Bruneau became PLT. CO. of the Services PLT. The Detachment Administrative Section has maintained the Unit's records, basic correspondence, SRB audits, and reports during the period.

c. Intelligence. 23 new security clearance's were granted during the period.

d. Training.

- (1) During the course of the 12 months covered by this report, priority was placed on maintaining qualification and expertise of Redeye/Stinger Gunners. 140 hours have been devoted to Redeye/Stinger training. This training has consisted of Aircraft Recognition, Tracking Head Training, Map Reading, Communications, Small Unit Deployment and Tactics, and associated military training. The unit achived a 32% completion rate for MCI courses and a 97% passing rate of the PFT. An exemption was given for Rifle qualification.
 - (2) Unit training accomplished during ATD is as follows:

- (f) During 9July-23July 1983, 1 Officer and 12 enlisted personnel participated in CAX 8-83, conducted at MCAGCTC, 29 Palms, California.
- (g) During 9July-23July 1983, 1 GYSGT. and 7 enlisted personnel attended MOS training at the Communication School, MCB, Camp LeJune, North Carolina.
- (h) During 9July-23July 1983, 2 enlisted personnel attended the formal Redeye/Stinger school conducted by the U. S. Army, at Fort Bliss, El Paso, Texas.
